

**DONATION AGREEMENT TO BECOME A CORPORATE MEMBER OF  
FOUNDATION FOR CORPORATE SOCIAL RESPONSIBILITY**

The Company wishes to become a Corporate Member of the Foundation by first  
signing the Foundation's Responsibility Statement and entering into membership  
of the Foundation by means of this Donation Agreement.

**RULES FOR COMMON USE OF DISTINGUISHING SIGNS OF THE OTHER  
PARTY**

1. Throughout the term of the Agreement, the Company will be entitled to use the logo of the Foundation containing the Gold Seal of Approval as a "Socially Responsible Company," and the name of the Foundation in its advertising and promotional materials related to the Foundation's activities, and whereas the Foundation will be entitled to use the logo of the Company in its advertising and promotional materials supporting the activities of the Foundation.
2. In addition, the Company may request that the Foundation permit the use of "the logo of the Foundation," and the "name of the Foundation," to denote the Company's' products or services. Approval will be granted in writing.
3. "The logo of the Foundation" shall be provided electronically to the Company upon the signing of this agreement. The logo of the Company will be provided to the Foundation electronically upon signing of this agreement.

**OBLIGATIONS AND ACTIVITIES OF THE COMPANY**

The Company agrees to become a Member of the "Foundation for Corporate Social Responsibility" and hereby agrees to the following:

- A. The Company agrees to sign and abide by the Foundation's Social Responsibility Statement.
- B. The company will support the activities of the Foundation by contributing the equivalent of 12,000 PLN of in-kind contributions each year to the Foundation.

## OBLIGATIONS OF THE FOUNDATION

- A. If requested, the Foundation will provide the Company with required assistance in the planning and implementation of the Company's Social Responsibility program.
- B. The Foundation will permit the Company to use the Foundation's "Gold Seal of Approval" logo designating the Company as a "Socially Responsible Company," and the name of the "Foundation for Corporate Social Responsibility."
- C. The Foundation will include the Company in all advertising and promotional programs carried out by the "Foundation for Corporate Social Responsibility," and to place the company's logo and other agreed upon distinguishing signs of the Company on the promotional and advertising materials published by the Foundation

## ENTRY INTO FORCE AND VALIDITY OF AGREEMENT

1. The Agreement shall enter into force on the first day of \_\_\_\_\_.
2. The Agreement is concluded for a period of three years. If no Party provides the other Party with a written declaration to the contrary 30 days prior to the expiration of this agreement, the Agreement shall be extended for a subsequent period of one year. The same one-year extension provision will apply each subsequent year thereafter.

## FINAL PROVISIONS

Each Party represents that it has the right and has been duly authorized to enter into this Agreement and to perform its obligations hereunder. All amendments hereto must be in writing and executed by both Parties. This Agreement is drawn up in the English language. Each Party shall receive one copy.
